NCBI Overview

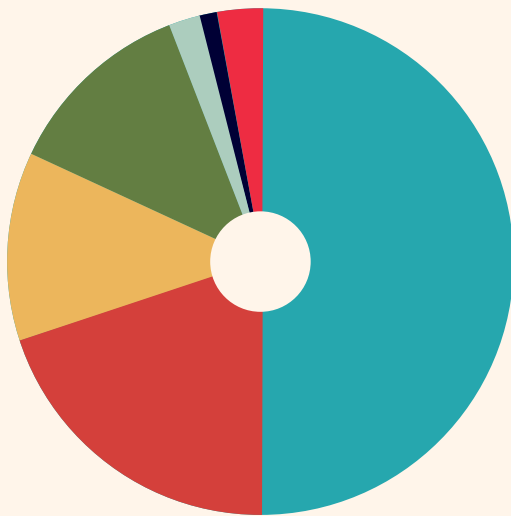
Overview

- Registered as an Incorporated Society in 1998.
- Napier City Business Inc. (NCBI) is an independent organisation, entirely separate from Napier City Council (NCC) or any other body.
- NCBI currently employs three staff (that equate to 1.7 FTE's).
- Funded by way of a targeted levy on all commercial buildings in the rateable area (see membership zone map on page 8), plus a contribution from Napier City Council.
- Current membership totals 450 businesses & 3,000 staff (approximately).

Membership Zone

- All businesses that fall within this area are automatically NCBI members by nature of falling within the rateable area.
